There are a few basic requirementar all J1 Exchange Visitors:

- 1) Intent to pursue appropriate activity
- 2) Intent to return to home **co**try (as determined by ConsulaffiCer)
- 3) Appropriate background for program activity (itlee J1 Exchange/isitor meets appropriate polication requirements)
- 4) Adequate English proficiency a letter from your university stating proficiency will be adequate

LIMITATIONS ±DURATION OF STAY AND EMPLOYMENT

- x Limited to aminimum stay of 3 weeks and maximum stay of 24 months for nondegree students
- x Must be enrolledor full-time studyfor duration of program
- x May work up to 20 hours on campus during regular university semesters. May work40 phours per week on campus during holidays (i.e. Spring Break, Christmas vacation)
- x May qualify for Academic Training work authorization for offempus employment
